Charlotte City Councilwoman Dimple Ajmera will be speaking on the “Sustainable and Resilient Charlotte by 2050 Resolution,” the Strategic Energy Action Plan and Charlotte’s tree canopy at the Sept. 12 Lunch with the League.

Passionate about creating a sustainable, equitable and safe Charlotte, she currently chairs the city’s Environmental Committee which is focused on committing Charlotte to become a global leader in environmental sustainability while balancing economic growth and preserving our natural resources.

The 2050 Resolution details the city’s goal to reduce city-wide gas emissions to meet proposed carbon dioxide levels. Read the resolution [here](#).

Ms. Ajmera was elected to a first term on Charlotte City Council in November 2017. She previously served one year as an appointed District 5 representative. Prior to her election as Councilwoman, Ajmera was twice appointed to the Board of Commissioners for the Charlotte Housing Authority (CHA). Dimple is widely known for her leadership in bringing new life and opportunities to the former 69-

acre Eastland Mall site.

She has the proud distinction of being the first Asian-American and the youngest woman to serve on the Charlotte City Council.

PRESIDENT'S MESSAGE: LET'S TALK FINANCES!

Dear Colleagues,

Here's hoping you had an enjoyable summer and are ready to commit to a variety of upcoming League projects.

One such project entails raising funds for the **100th Anniversary Celebration in 2020** of the founding of the League of Women Voters. All across the country, the national league (LWVUS) and local and state leagues have begun planning for this auspicious event.

In Charlotte Mecklenburg, we look towards a big celebration on February 29, 2020 at the Meridien Hotel in uptown Charlotte. Plans are tentative, however, because we will need to raise \$50,000 for the celebration, which will hopefully include funding to support on-going League projects such voter registration at high schools and naturalization services, community education forums, our annual meeting and other League expenses.

We are approaching private persons and corporations to sponsor the celebration at different funding levels, but we also need the financial support of all League members.

Here's what we are discussing: encouraging members to pay for tickets at \$100 per person and inviting family and friends to do likewise. We believe that allowing you time to save will not present a hardship to you. We have a deadline for reserving the hotel at the beginning of the new year, with subsequent installment payments. We need your help to pull off a truly once-in-a-lifetime event!

The second financial consideration is any contribution you can make (in addition to your dues) to help **pay for the new rent increase** levied by the Midwood International Cultural Center because it now has to pay Charlotte-Mecklenburg Schools \$35,000 a year to lease the property, instead of the previous \$1 a year agreement.

The third consideration is your **support of our online Vote411 challenge**. Your contribution will be matched dollar for dollar by a generous donor. The deadline for your gift is September 15; you can go to our website, goleaguego.org, to see how to pay.

Fair Elections Action Team (FEAT)

Reasonable Redistricting Reform attracted a crowd to the League Education Center for a workshop featuring Dr. Jennifer Bremer from the LWVNC and

LWVCM Fair Elections Action Teams. She presented the League's findings from a study of recent legislation in 15 other states to prevent gerrymandering and ways to remedy North Carolina's gerrymandered voting districts

Possible solutions developed from the research have been presented to North Carolina legislators as a Legislator's Guide to Reasonable Redistricting Reform: Findings from the League of Women Voters White Paper on Emerging Alternatives for Redistricting Reform – 22-



July 2018. You can view the entire guide [here](#).

In addition to creating an independent commission with the Legislature's involvement, the League of Women Voters found it's also important to make the commission's decisions final – and to include citizens and impartial experts on the commission.

While the paper does not recommend a specific plan, it lays out options and gives the pros and cons. The goal is to start with an independent commission and build consensus on a workable solution—and get it done before the next required redistricting in 2021.

5 Principles for Reasonable Redistricting Reform:

- 1 - Include a role for the legislature in the process, such as naming some of the commissioners
- 2 - Include citizens and/or impartial experts as commission members
- 3 - Set strict rules for the commission's work that:
 - apply traditional redistricting standards (compact, contiguous, communities of interest)
 - do not allow the use of partisan data or partisan objectives
 - use voting rules that require bipartisan support for the maps
- 4 - Provide for extensive citizen participation and transparency
- 5 - Make the maps final on the commission's vote

Redistricting Rulings



NC Voters Win (Again)

In a victory for NC Voters, a federal court struck down the state's congressional district map as an unconstitutional partisan gerrymander—for the second time.

"We look forward to the day North Carolinians will have fair maps that truly represent our great and diverse state," said LWV North Carolina co-president, Janet Hoy.

"North Carolina voters have waited far too long for districts that reflect our populations equally. Now is the time to end partisan gerrymandering once and for all."

How can North Carolina implement reasonable redistricting reform? A LWV North Carolina study cites five main principles lawmakers can use when crafting legislation to reform redistricting.

Chris Carson, president of the LWVUS, wrote the above about the NC League's Appeals Court victory this week as her first entry on her weekly update. The national League is watching the North Carolina cases closely, and President Carson reports regularly about them. Sign up for her updates [here](#).

Take note - election information in this Voter is subject to change.

It was a three-judge panel of the US Court of Appeals Fourth Circuit that found the NC Legislature's latest congressional district map unconstitutional partisan gerrymandering in a suit brought by the League of Women Voters of NC and Common Cause.

Previously, courts had thrown out NC congressional maps for racial gerrymandering after LWVNC and Common Cause sued.

"There's no way out of this situation that doesn't involve confusion and chaos," according to **Vann R. Newkirk**, writing in [The Atlantic](#), Aug. 29, 2018.

Newkirk said the certainty of more drama recalls an important issue that was highlighted by Judge James Wynn, who wrote for the panel's majority. "**We continue to lament that North Carolina voters now have been deprived of a constitutional congressional districting plan—and, therefore, constitutional representation in Congress—for six years and three election cycles,**" Judge Wynn wrote.

The ruling ordered the General Assembly to redraw the 13 congressional districts or the court would hire a "special master" to do it. NC legislators said they would ask the Supreme Court to intervene, according to the [Charlotte Observer](#).

Or alternatively, the judges said the state could forgo new primaries and just continue with the general election in November using the current candidates, but running for the new districts. Another possibility would be to use the November election as a primary and hold a general election later.

Therefore, while the ruling on the League's lawsuit successfully moved the state another notch (*for the time being*) toward constitutionally elected Representatives, it may be a very unusual election with new dates and candidates in the offing. At least, that is the way it looks at this writing.

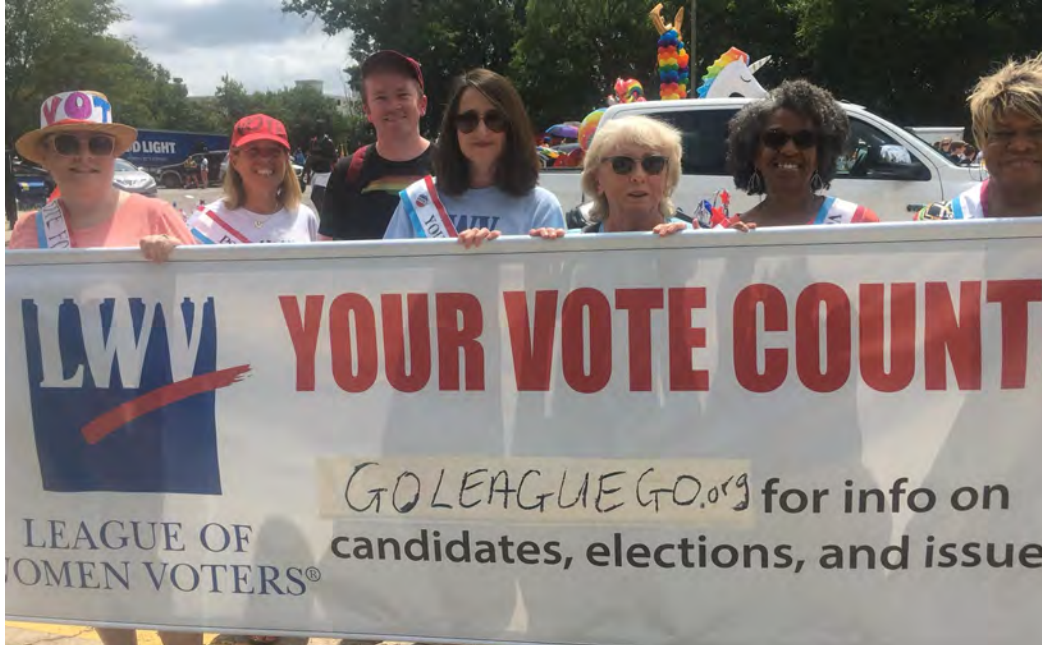
